We show regard and appreciation for all people from all walks of life and honour human difference and diversity.



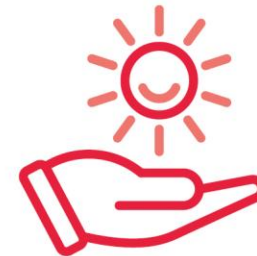
Collaboration
